then being an unlawful user of a controlled substance as defined in Title 21, United States Code, Section 802, did knowingly possess firearms, to wit: a Ruger, Model SP 101, .357 caliber revolver; a Marlin Glenfield, Model 60, .22 caliber rifle; a Browning Arms, .22 caliber rifle; and a Westernfield, Model M155A, .410 gauge shotgun, said possession being in and affecting interstate commerce and said firearm having been shipped and transported in interstate commerce, all in violation of Title 18, United States Code, Sections 922(g)(3) and 924(a)(2).

<u>Count Ten</u> (Illegal Use of Communication Facility)

On or about July 3, 2018, in the State and Federal District of Nevada,

TIANNA CHRISTINA CORDOVA,

defendant herein, did knowingly and intentionally use any communication facility, a telephone located at the Nevada Southern Detention Center, to communicate with

J.L.P., who is not charged in this indictment, who was using a cellular telephone with an assigned number of (702) XXX-6351, in facilitating the commission of any act or acts constituting a felony under Title 21, United States Code, Sections 841(a)(1), (b)(1)(C) and 846, that is, Conspiracy to Distribute Buprenorphine and Naloxone (Suboxone), a Schedule III controlled substance, in violation of Title 21, United States Code, Section 843(b).
