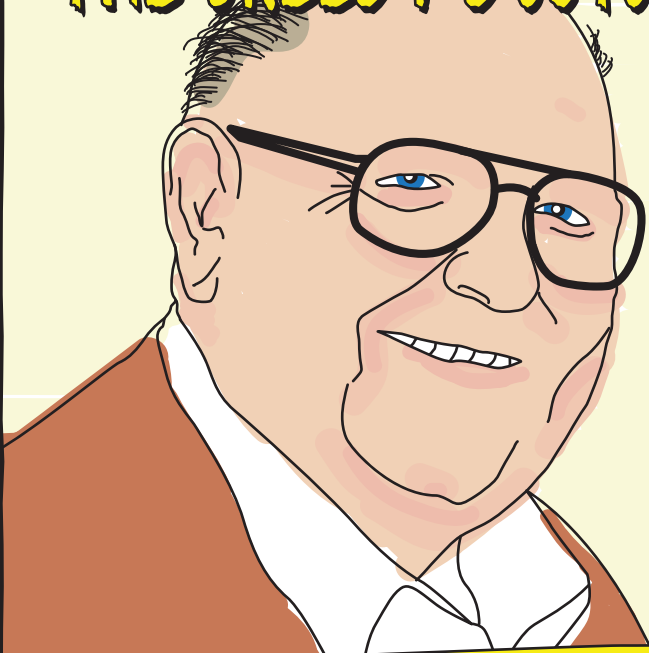

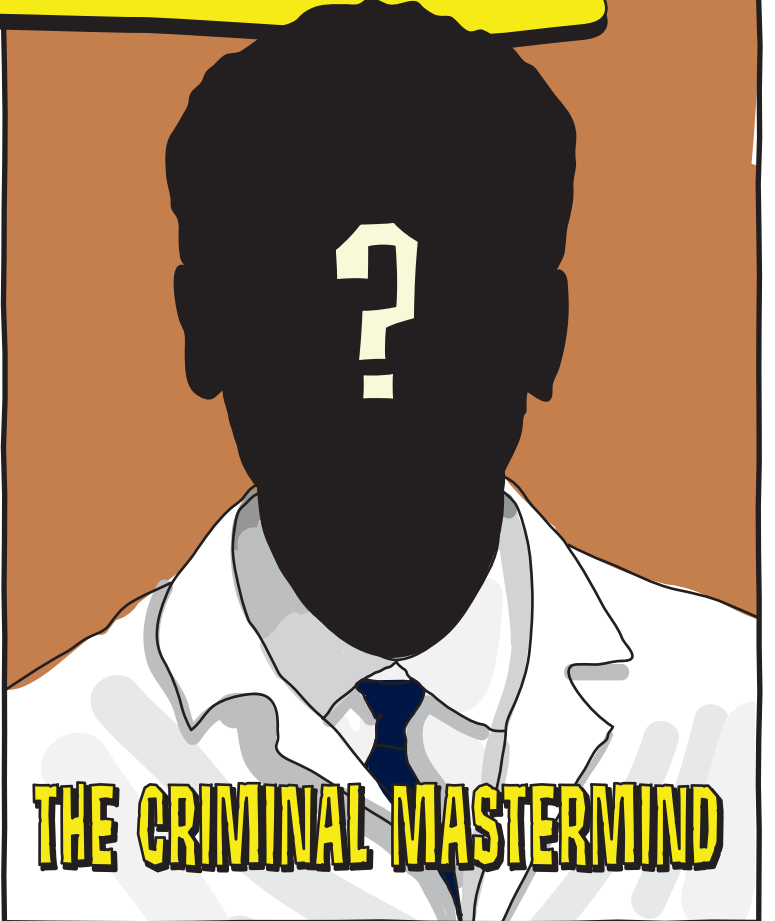

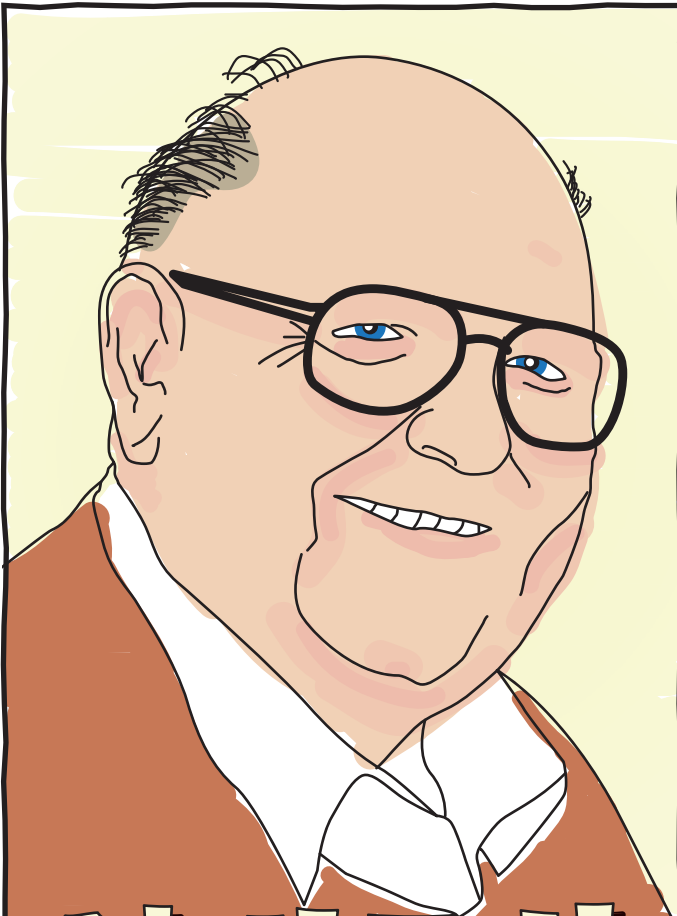

GUILTY!

"DR." KURT WALTER DONSBACH
PLED GUILTY TO UNLAWFULLY SELLING
FAKE MEDICINE WITH INTENT TO FRAUD,
PRACTICING MEDICINE WITHOUT A LICENSE,
AND ATTEMPTED GRAND THEFT.
CONVICTED APRIL 2011.
SENTENCED TO 1 YEAR IN COUNTY JAIL.

DONSBACH, OF BONITA, CA, IDENTIFIED HIMSELF AS A CHIROPRACTOR AND NATUROPATHIC DOCTOR, USING HIS RADIO SHOW TO OFFER PATIENTS "NATURAL" REMEDIES TO SERIOUS HEALTH CONDITIONS LIKE RHEUMATOID ARTHRITIS AND LATE STAGE CANCER BUT INSTEAD SOLD THEM COUNTERFEIT MEDICATIONS MADE OF DANGEROUS AND ILLEGAL INGREDIENTS.

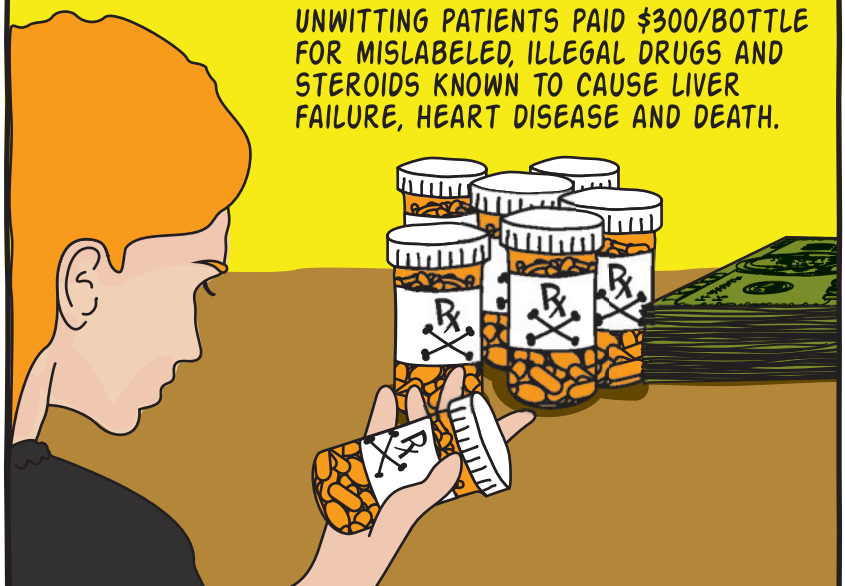

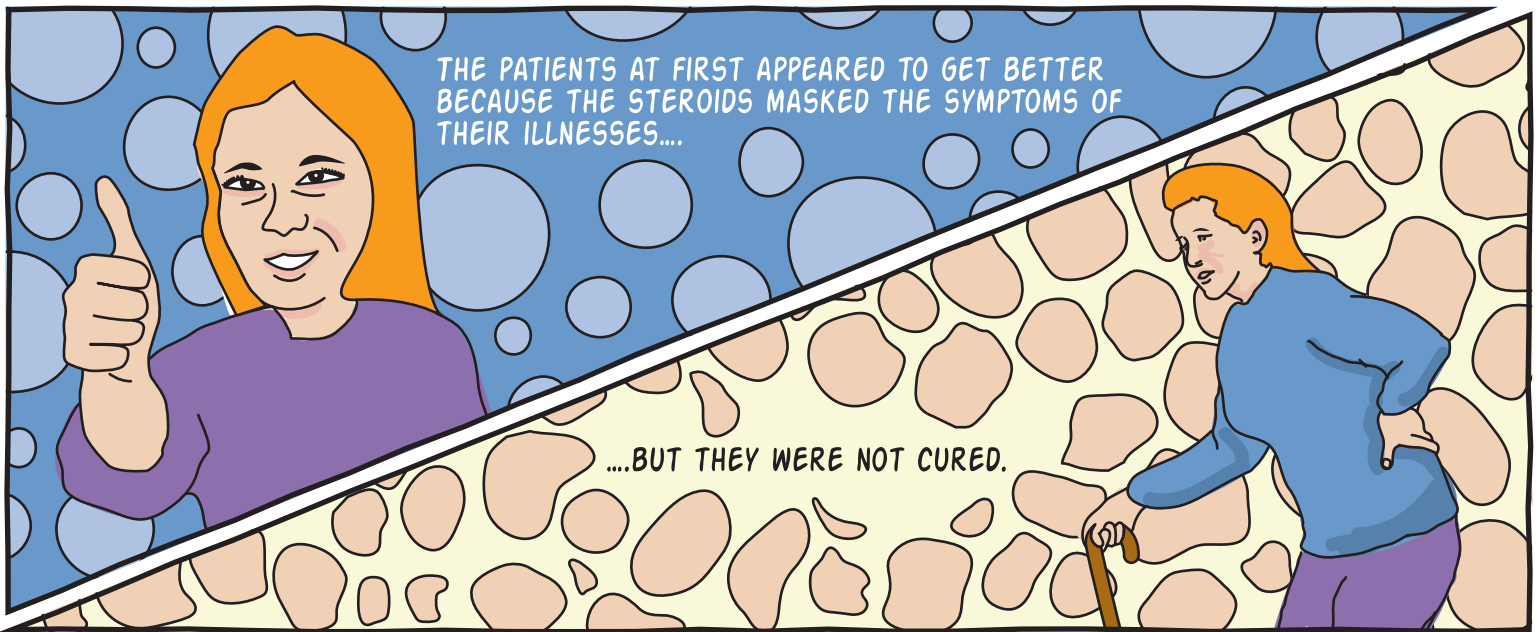

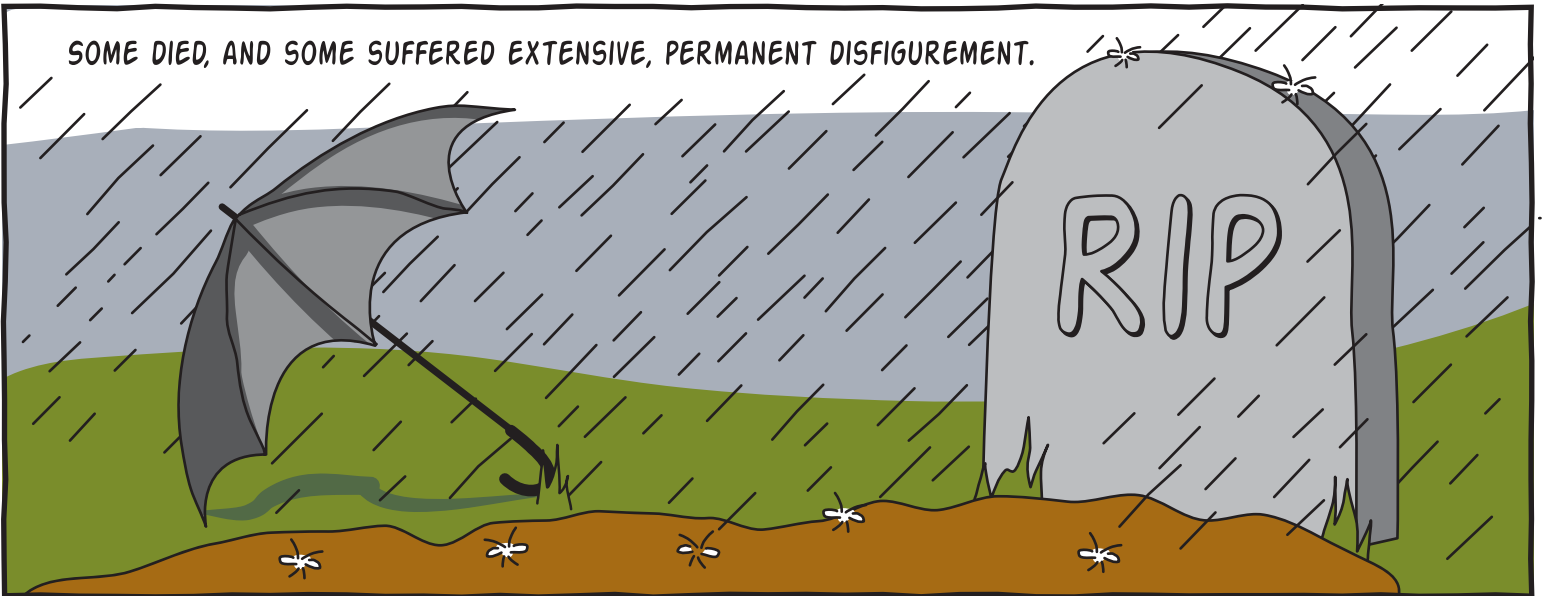

BECAUSE THE STEROIDS MASKED THE SYMPTOMS OF

KURT WALTER DONSBACH PLED GUILTY ON APRIL 15, 2011 TO 13 FELONY CHARGES INCLUDING SELLING FAKE DRUGS TO CANCER PATIENTS, PRACTICING MEDICINE WITHOUT A LICENSE, AND ATTEMPTED GRAND THEFT. HE WAS SENTENCED TO ONE YEAR IN COUNTY JAIL AND PROBATION OF TEN YEARS.

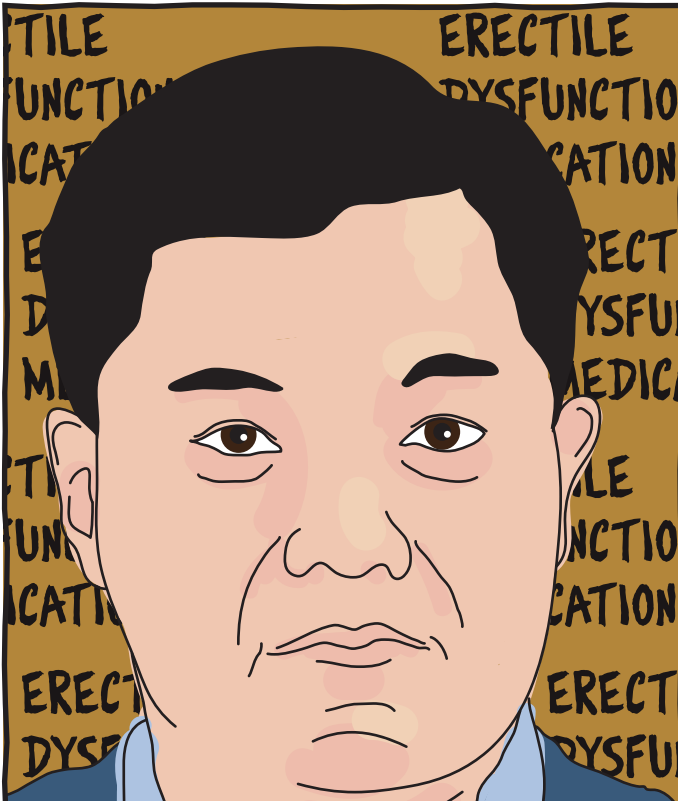

GUILTY!

KEVIN XU

CONVICTED OF FOUR FELONY COUNTS OF PARTICIPATING IN A CONSPIRACY TO TRAFFIC COUNTERFEIT PRESCRIPTION DRUGS INTO INTERSTATE COMMERCE.

CONVICTED JANUARY 20, 2009

SENTENCED TO 78 MONTHS IN FEDERAL PRISON WITHOUT PAROLE.

KEVIN XU SAID HE WAS A LEGITIMATE MAKER OF GENERIC DRUGS IN CHINA AND STARTED OUT MAKING SOME EXTRA MONEY BY SELLING FAKE ED DRUGS ONLINE, WITHOUT SUFFICIENT ACTIVE INGREDIENTS.

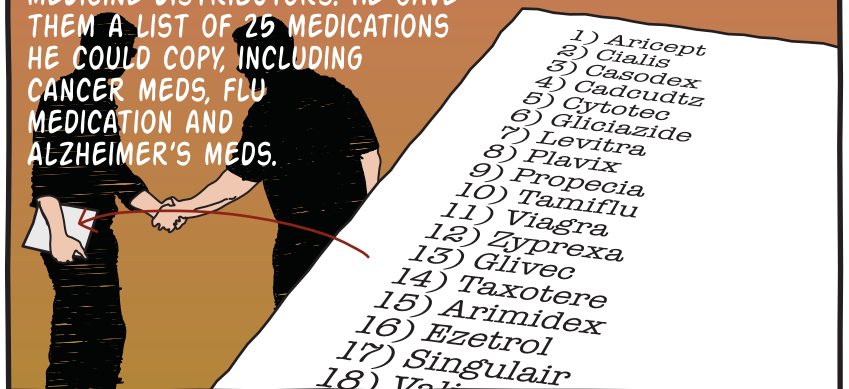


AFTER HIS INITIAL SUCCESS COPYING THE METHODS OF LEGAL DRUG MAKERS TO REPLICATE BATCH NUMBERS TO FOOL THE LAW, HE EXPANDED HIS BUSINESS INTO EUROPE.



AFTER SIX YEARS OF SMUGGLING FAKE MEDS INTO EUROPE, USING OTHER ASIAN COUNTRIES TO TRANS-SHIP THE PACKAGES, HE SOUGHT OUT U.S. FAKE DRUG DISTRIBUTORS TO EXPAND HIS BUSINESS.

THE U.S. WAS CHALLENGING TO INFILTRATE. ICE AGENTS FOUND HIM FIRST, AND POSED AS LARGE VOLUME U.S. MEDICINE DISTRIBUTORS. HE GAVE THEM A LIST OF 25 MEDICATIONS HE COULD COPY, INCLUDING CANCER MEDS, FLU MEDICATION AND ALZHEIMER'S MEDS.



BUT THE 25 MEDICATIONS WERE FAKE, WITH VERY LITTLE, IF ANY ACTIVE INGREDIENTS.

ONE SHIPMENT ALONE CONTAINED 200,000 BOXES AND OVER 1 MILLION FAKE PILLS.



XU PAID BRIBES TO CUSTOMS OFFICIALS TO GET THE COUNTERFEIT DRUGS INTO THE COUNTRY, AND HID THE PORT OF ORIGIN BY SENDING THE PRODUCTS THROUGH CANADA AND THE UK.



THANKS TO THE HARD WORK OF U.S. AGENTS, XU'S PIPELINE OF FAKE DRUGS WAS STOPPED FROM BREAKING OUR CLOSED SECURED DRUG SUPPLY CHAIN.



KEVIN XU WAS FOUND GUILTY IN U.S. FEDERAL COURT OF SELLING COUNTERFEIT DRUGS AND IS SERVING SIX-AND-HALF-YEARS IN JAIL. HE HAS ALSO BEEN NAMED IN AN INDICTMENT IN THE U.K.

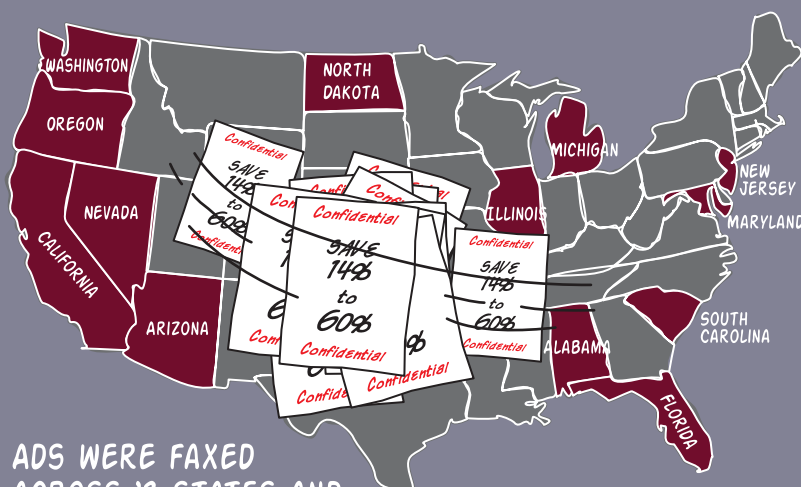

JAMES R. NEWCOMB

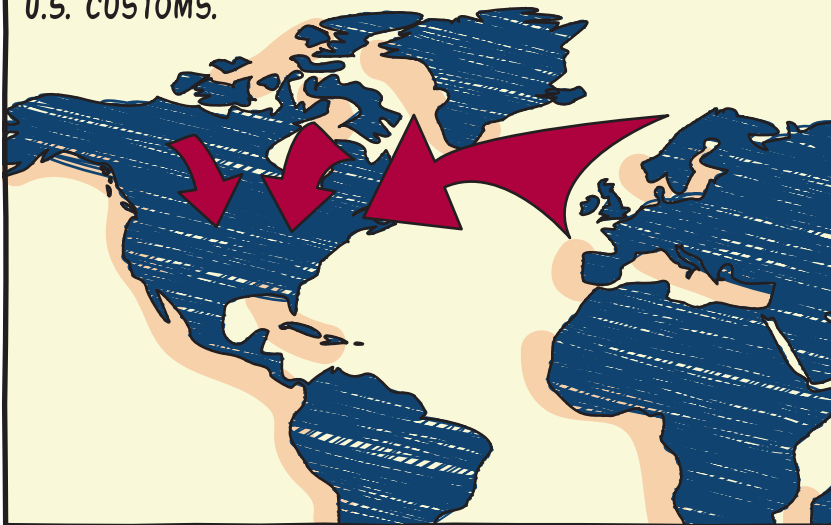
CONVICTED IN AUGUST 2012, SENTENCED TO TWO YEARS IMPRISONMENT, AND FORFEITED \$14 MILLION AND A LAND ROVER.

JAMES NEWCOMB FAXED ADS TO DOCTORS OFFERING 14% TO 60% OFF ON EXPENSIVE CANCER DRUGS WHILE ASKING DOCTORS TO KEEP THE PRICE LIST "CONFIDENTIAL."



ADS WERE FAXED ACROSS 13 STATES AND INVOLVING THIRTY FIVE DOCTORS

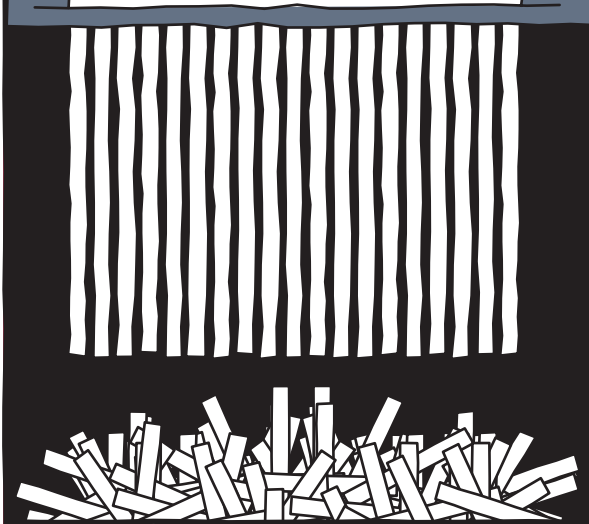
BUT NEWCOMB'S ASTONISHING SAVINGS CAME WITH A PRICE - THE DRUGS WERE ADULTERATED, UNAPPROVED FOR USE IN THE US AND COUNTERFEIT. PACKAGES SHIPPED FROM OTHER COUNTRIES WERE FALSELY MARKED "MEDICAL SAMPLES" TO AVOID SEIZURE BY U.S. CUSTOMS.



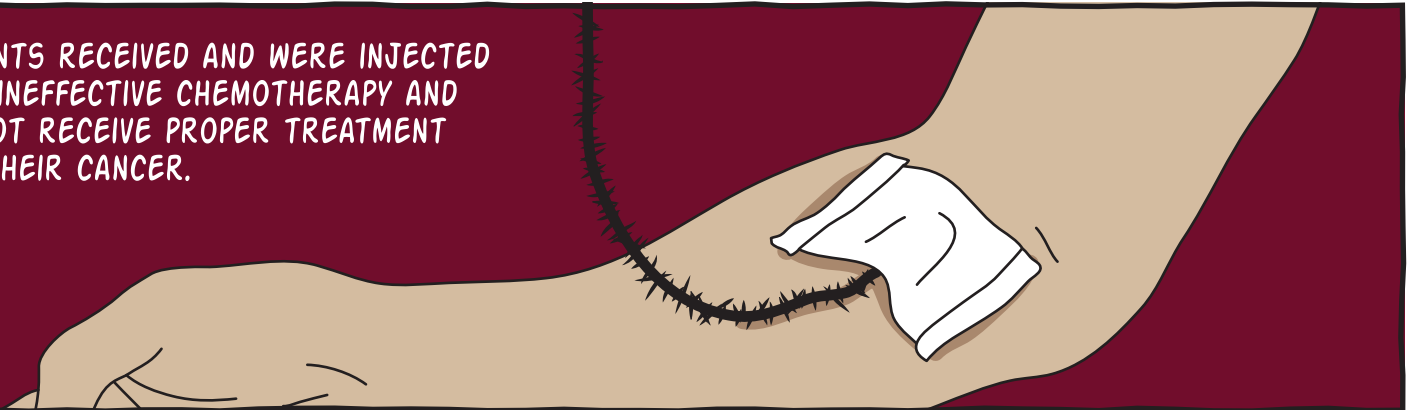
BUT, YOU GET WHAT YOU PAY FOR. DOCTORS RECEIVED COMPROMISED SHIPMENTS WITH RUPTURED COLD PACKS, AND SOME COMPLAINED THAT PATIENTS WERE HAVING HEALTH PROBLEMS DURING DRUG INFUSIONS.



TOLD THE FDA WAS ASKING QUESTIONS, NEWCOMB SHREDDED DOCUMENTS, WIPED COMPUTER HARD DRIVES AND CHANGED EMAIL ADDRESSES.



PATIENTS RECEIVED AND WERE INJECTED WITH INEFFECTIVE CHEMOTHERAPY AND DID NOT RECEIVE PROPER TREATMENT FOR THEIR CANCER.



JAMES R. NEWCOMB WAS CONVICTED IN AUGUST 2012. SENTENCED TO TWO YEARS IMPRISONMENT AND FORFEITED \$14 MILLION AND A LAND ROVER.

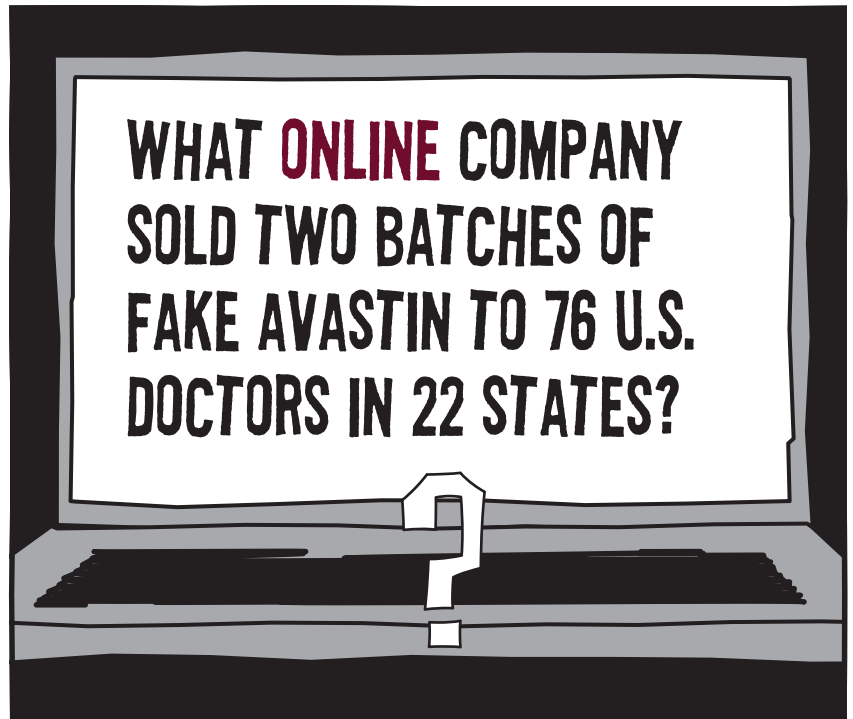
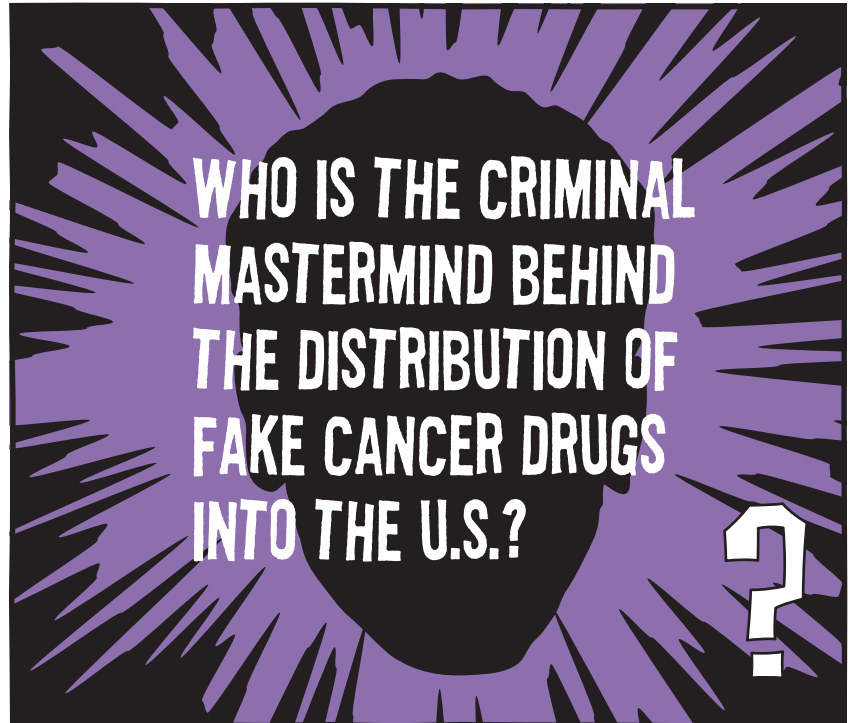

ALL HEALTHCARE PROFESSIONALS HAVE A UNIQUE DUAL ROLE IN PROTECTING PATIENTS. ON ONE HAND, THEY HAVE THE OPPORTUNITY TO SPOT THERAPEUTIC FAILURE AND TALK TO PATIENTS ABOUT HOW THEY FILL THEIR PRESCRIPTIONS. IF PATIENTS THEMSELVES BREAK THE SUPPLY CHAIN WITHOUT REALIZING THE RISKS, A HEALTHCARE PROFESSIONAL CAN DEMONSTRATE THE IMPORTANCE OF BUYING MEDICATIONS FROM SAFE SOURCES.

ADDITIONALLY, HEALTHCARE PROFESSIONALS OFTEN SOURCE MEDICATIONS FOR PATIENTS. IT'S NOT JUST PHARMACISTS WHO NEED TO KNOW ABOUT SAFE SOURCING, THE RECENT AVASTIN INCIDENT TEACHES US THAT PHYSICIANS NEED SAFE SOURCING EDUCATION TOO.
