 16 The United States of America, by and through its counsel of record, the United
 17 States Attorney for the District of Arizona, respectfully submits the following Sentencing
 18 Memorandum and Response to defendant Jacob Matthew Medina’s Objections to
 19 Presentence Investigation Report (ECF 127).

20 I. The Government Has No Objections to The Presentence Report

21 Counsel for the United States has reviewed the Presentence Investigation Report
 22 (“PSR”) and has no objection to the factual information contained in the PSR.

23 Additionally, the government has no objection to the guidelines calculation proposed in
 24 the PSR (shown below with the U.S.S.G. 3E1.1 adjustment):

6 II. Government's Response to Defendant's Objections

7 Defendant objects in his supplemental sentencing position (ECF 127, hereinafter
8 "Def. Obj.") to two aspects of the Probation Officer's guidelines calculation: an
9 adjustment for making misrepresentations regarding the drugs he sold over the dark web,
10 and assessments of criminal history points for his prior convictions. Because the PSR's
11 guideline calculations properly account for the nature and scope of defendant's criminal
12 conduct in the instant offense, the Court should overrule defendant's objections.

13 A. Medina Offered Illegal Drugs on The Dark Web

14 Defendant sought out the cover of the dark web to operate an illicit enterprise
15 selling dangerous drugs to individuals throughout the United States. Defendant, calling
16 himself "ghost831," advertised heroin, methamphetamine, and oxycodone for sale on the
17 "Dream Market" over a period than spanned 2017 to 2019.

18 Defendant's activity on the Dream Market, an internet site accessible only on the
19 dark web, began in December 2017, as established by his vendor profile. (Exhibit A,
20 USPIS report.) The profile for ghost831 lists ghost831's "join date" as December 19,
21 2017. (Ex. A at Bates 872.) Under the "Terms and conditions" page of the profile,
22 ghost831 stated the following: "Hello My fellow Dream community, im ghost. a New
23 vendor on Dream but not a new vendor to the DM world. i can supply many things at a
24 very great price. . . . I have nothing but great quality stuff and I cannot wait to start doing
25 business with all of you." (Ex. A at 873.) Ghost831's statement about not being a new
26 vendor on the dark web was confirmed by the information that law enforcement obtained
27 about defendant's activity on the dark web, as summarized in paragraph 9 of the PSR.
28 That investigation found that ghost831 was first registered October 17, 2012 on the dark
web. (PSR ¶ 9.)

1 On the Dream Market, the vendor site for ghost831 was registered to defendant--
2 which defendant confirmed by fulfilling orders placed in response to his dark web listings
3 for illegal drugs. For example, on November 30, 2018, undercover investigators
4 conducted an undercover purchase of 3.5 grams of heroin from ghost831's listings. (PSR
5 ¶ 5.) Defendant filled this order on December 4, 2018, mailing the heroin from the
6 Glendale, Arizona, Arrowhead Post Office, using a pre-paid visa card as payment. (PSR
7 ¶¶ 6-7.) Later that month, undercover investigators again ordered drugs, this time
8 methamphetamine, from ghost831. (PSR ¶ 10.) Defendant again fulfilled the order.
9 (Exhibit B, report of fingerprint analysis.) At the time of the second undercover
10 purchase, investigators documented defendant's offerings on his vendor page. (Ex. A at
11 875.) The listings included the following:

- 12 • "3.5 Gram High Quality Black Tar Heroin \$260.00" (corresponding to the
13 November 2018 undercover purchase);
- 14 • "1 Gram 90+% Methamphetamine \$50.00" (corresponding to the
15 December 2018 undercover purchase);
- 16 • "Oxycodone 30MG M-Box (Pressed)"

17 (*Id.*) On his site, ghost831 described his methamphetamine and heroin as "high quality"
18 and said that the oxycodone was "powerful stuff." (Ex. A at 873.)

19 The description of ghost831's oxycodone as "30MG M-Box" is significant
20 because it indicates a manufacturer's trade mark (Mallinckrodt Pharmaceuticals) for a
21 pharmaceutical tablet that contains 30 mg of oxycodone hydrochloride. (*See* Exhibit C,
22 USPIS laboratory report, at Bates 664.) When legitimate, this tablet is blue and has the
23 letter "M" inside a box on one side; however, these pills are often counterfeited and
24 found to have fentanyl, as was the case with defendant's pills (*id.*). Although ghost831
25 told dark web shoppers that he was offering oxycodone pills containing 30 mg of
26 oxycodone, those pills in fact contained fentanyl, as confirmed by laboratory testing of
27 the M30 pills recovered from defendant's residence and from mailed packages in March
28 2019. (PSR ¶¶ 13, 14, 15; Ex. C (finding that that the light-blue, round, tablets impressed
with "M" on one side and "30" on the scored side contained fentanyl).) In addition, the

1 search of the residence and defendant's arrest caused an attempted UC drug purchase
2 from ghost831 to be aborted by support—further confirming defendant's identity as
3 ghost831. (See PSR ¶ 18; Exhibit D, USPIS report¹, at Bates 229 & 234.)

4 At the time that defendant's residence was searched in March 2019, investigators
5 again captured the ghost831 vendor page on the dark net, and it showed that defendant
6 had continued to offer "oxycodone" pills. (Ex. D at 232.) The listings on the vendor
7 page no longer included methamphetamine (as offered in December 2018), but still
8 offered "BTH" (black tar heroin) and "Oxycodone 30MG M-Box." (*Id.*) There were
9 multiple oxycodone listings by ghost831, one with the notation "LVL 3." (*Id.*)
10 Investigators found numerous bags of counterfeit blue M30 pills in defendant's residence,
11 including a bag marked "Lvl 3." (Exhibit E, evidence photograph.)

12 As it had previously, the ghost831 vendor profile page discussed the drugs that
13 defendant was offering, including the representation that the heroin was "high quality."
14 (Ex. D at Bates 230.) The vendor page also had the following statement:

15 FYI those that say these are fentanyl. . THEY ARE NOT!
16 (*Id.* (punctuation and capitalization in original).) This denial was repeated elsewhere on
17 the vendor profile. (*Id.*)

18 **B. Defendant's Sentence Should Reflect His False Representations that He**
19 **Was Selling Oxycodone**

20 The PSR increased defendant's guideline offense level pursuant to 2D1.1(b)(13),
21 which provides an adjustment if the defendant knowingly misrepresented or knowingly
22 marketed a substance containing fentanyl (or a fentanyl analogue) as another substance.
23 (PSR ¶ 30.) Defendant claims that the enhancement should not be applied to him
24 because: (1) there is insufficient evidence that he made any knowing misrepresentations
25 or marketing; and (2) the purchasers of the pills that defendant distributed knew what was

27 ¹ Although the USPIS March 2019 data captured the ghost831 vendor site as of March 6, the
28 vendor page noted that the vendor was last active "two days ago," which is consistent with
activity by defendant prior to his arrest on the day of the search warrant at his residence. (Ex. D
at Bates 229.)

1 in the pills. (Def. Obj. 15-17.) These claims are not supported by the evidence in this
2 case and should be rejected.

3 First, the ghost831 vendor page on the dark web clearly sold the M30 pills as
4 “oxycodone.” Every listing of oxycodone by ghost831 provided the full name of the
5 drug being offered--and went even further by describing a purported trade inscription
6 (“M-Box”) and a purported amount (“30MG”). Defendant was found with hundreds (if
7 not thousands) of M30 pills at his residence, and he and his co-defendant mailed even
8 more M30 pills. (*See e.g.*, Exhibits E, F, G, evidence photographs.) Yet none of the pills
9 recovered by law enforcement contained oxycodone hydrochloride. (Ex. C.) None of the
10 M30 pills were diverted pharmaceutical tablets. The M30 pills possessed and distributed
11 by defendant were entirely counterfeit. The evidence in this case demonstrates that
12 defendant was “ghost831,” as he had not only the drugs and significant drug proceeds
13 (\$31,000 cash) at his residence, but also pill press components, binder agent, packaging
14 supplies and extensive customer lists. (PSR ¶¶ 14, 20.) The evidence proving that
15 defendant was ghost831 also includes the undercover purchases (PSR ¶¶ 5-7, 10), as well
16 as the fentanyl overdose by the ghost831 customer whose address was found at
17 defendant’s residence (PSR ¶¶ 12, 14 (regarding overdose victim C.K.)).

18 Defendant attempts to divert the inquiry from his own knowledge by pointing to
19 one customer who stated--after a friend’s fatal fentanyl and cocaine overdose--that the
20 customer knew that the pills he purchased from ghost831 and provided to his friend were
21 counterfeit oxycodone. (Def. Obj. 15-16; *see* PSR ¶ 11 (recounting investigation of
22 overdose death of victim V.K.)) As a threshold matter, defendant fails to identify any
23 action he undertook to cause this single customer to form the opinion that he pills that he
24 received were counterfeit oxycodone, especially in light of the pills being listed as
25 “oxycodone.” But more importantly, defendant’s argument misses the point of the
26 adjustment, which is a defendant’s knowledge, not that of his customers. In explaining
27 its rationale for adding the misrepresentation adjustment to 2D1.1, the Sentencing
28 Commission stated:

1 The Commission learned that while fentanyl has long been a drug of abuse,
2 there are several indications that its abuse has become both more prevalent
3 and more dangerous in recent years. . . . The Commission received
4 testimony and other information indicating that fentanyl and its analogues
5 are often trafficked mixed with other controlled substances, including
6 heroin and cocaine. In other instances, fentanyl is placed in pill or tablet
7 form by drug traffickers. Although some purchasers of these substances
8 may be aware that they contain fentanyl (or even seek them out for that
9 reason), others may believe that they are purchasing heroin or
10 pharmaceutically manufactured opioid pain relievers.

11 Because of fentanyl's extreme potency, the risk of overdose death is great,
12 particularly when the user is inexperienced or unaware of what substance
13 he or she is using. To address this harm, the amendment adds a new specific
14 offense characteristic at §2D1.1(b)(13) to provide for a 4-level increase
15 whenever the defendant knowingly misrepresented or knowingly marketed
16 as another substance a mixture or substance containing fentanyl or a
17 fentanyl analogue.

18 USSG App. C, amendment 807 (Reason for Amendment) (2018). Here, defendant's
19 listings and sales of counterfeit oxycodone pills were linked to the kind of harm discussed
20 by the Commission. Victims C.K. and V.K. suffered fatal overdoses involving fentanyl.²

21 Though the adjustment does not require a defendant to have knowledge of actual
22 overdoses by his customers, there was at least one overdose discussed on the feedback
23 section of defendant's dark web vendor site. In particular, one of ghost831's customers
24 had posted: "Timely shipping. but I had a gal OD on one pill." (Exhibit H, USPIS report,
25 at Bates 693.) Other parts of the vendor site show that defendant had actual knowledge
26 that some of customers believed that the pills he sold contained fentanyl, causing him to
27 post denials that the pills contained fentanyl. (Ex. D at Bates 230.) The only pills sold
28 on defendant's vendor site were listed as oxycodone, and his fentanyl denials were false.
The facts of defendant's offense warrant the guidelines increase for his
misrepresentations.

² Victim D.K., who overdosed but survived, was also linked to defendant's dark web site. (PSR ¶ 19.)

1 **C. Defendant’s Criminal History Should Reflect His Relevant Conduct**

2 In his supplemental sentencing position, defendant objects to calculations
3 pertaining to his oldest criminal conviction and his most recent. (Def. Obj. 17-21.)
4 Because they both rest on a misapprehension of his relevant conduct, they should be
5 overruled.

6 According to defendant’s sentencing position, his criminal conduct in this case
7 commenced in November 2018 “at the earliest.” (Def. Obj. 18.) Therefore, he objects to
8 the assignment of points for his juvenile conviction (PSR ¶ 39), and for committing the
9 instant offense while under a criminal justice sentence for a prior conviction (PSR ¶ 44).
10 The Guidelines, however, make clear that, for the purpose of calculating criminal history,
11 a defendant is responsible for all relevant conduct of a defendant’s offense, not just
12 offense conduct that takes place after law enforcement first encounters a defendant.

13 In terms of the relevant guidelines provisions for these criminal history
14 calculations, each one has an application note that specifies that the analysis of the
15 “instant offense” includes “relevant conduct” as defined in the guidelines. *See* U.S.S.G.
16 § 4A1.1(d) and Application Note 4; U.S.S.G. § 4A1.2(d)(2)(B) and Application Note 8.
17 Section 1B1.3(a)(1)(A) states that that relevant conduct includes “all acts and omissions
18 committed, aided, abetted, counseled, commanded, induced, procured, or willfully caused
19 . . . by the defendant that occurred during the commission of the offense of conviction, in
20 preparation for that offense, or in the course of attempting to avoid detection or
21 responsibility for that offense.” Here, defendant does not dispute the PSR’s factual
22 statements in paragraph 9 describing his conduct prior to November 2018, but he
23 contends that the earlier conduct did not involve illegal activity, and that he was
24 incarcerated for a period of time and could not have participated in the instant offense;
25 however, neither of these assertions preclude the conduct from occurring during the
26 offense or in preparation for the offense. Relevant conduct does not require that the
27 defendant’s acts be illegal or be admitted by the defendant.
28

1 In addition to the facts set forth in Paragraph 9 and discussed above, the
2 documentation of defendant's dark web vendor site shows that he became active on the
3 Dream Market on December 19, 2017. (Ex. A at Bates 872.) The vendor information
4 documented in late 2018 also showed that in the approximate year that he had been on the
5 Dream Market, ghost831 had been reviewed by 110 customers, with a rating of 4.96 (out
6 of 5 stars). Defendant offered only illegal drugs for sale when on the Dream Market, and
7 his other activity during that time, such as the purchase of binding agent (PSR ¶ 9), is
8 consistent with him fulfilling drug orders. Employing a conservative analysis,
9 defendant's offense in the instant case commenced on December 19, 2017. If the Court
10 were to use this date, it could still find that the earlier activity was in preparation for the
11 instant offense. If the Court does not so find, it should still overrule defendant's
12 objection to the finding (PSR ¶ 44) that defendant committed the instant offense while
13 under community supervision in connection with his 2014 state drug felony (PSR ¶ 22).
14 As such, defendant's criminal history category would still be IV.

15 Government's Sentencing Recommendation

16 The investigation in this case revealed that defendant was a prolific dark web
17 vendor who used the pseudonym "ghost831" to advertise illegal drugs for sale through
18 the US Mail. Defendant's offense conduct is even more concerning because it was not
19 defendant's first drug crime--it began after defendant finished serving a three-year prison
20 sentence for another drug crime. Taking at face value defendant's claimed history of
21 substance abuse, the government finds any mitigation of this personal history is offset by
22 the increased risk that defendant will reoffend after he is released from custody. The
23 government acknowledges defendant's family support and hopes that the support will
24 facilitate defendant's rehabilitation. With respect to an appropriate sentence, and in
25 recognition of the facts of this case, the government recommends that defendant be
26 sentenced to 204 months imprisonment, to be followed by five years of supervised
27 release under the conditions proposed by the Probation Officer.
28

1 For the reasons stated above, and pursuant to the records and files of this case, the
2 government respectfully requests that the Court accept the plea agreement at the time of
3 sentencing, overrule defendant's objections motion for a variance, and sentence defendant
4 to a custodial term not greater than 204 months.





As of December 28, 2018, Postal Inspector Brandon still had not received anything. Postal Inspector Brandon logged onto NFusion and the Dream Market and sent Ghost831 a message inquiring about the purchase. On the same day, Ghost831 responded and asked when the order was placed and what address it was supposed to go to. Postal Inspector Brandon provided the information and Ghost831 stated, "I believe yours is in route ill check later today."

On December 31, 2018, Postal Inspector Brandon sent Ghost831 another message inquiring about the purchase. Ghost831 replied, "We know we checked the tracking and it's lost we gave you 3.5 and sent you a new one we're sorry for the inconvenience."

On January 4, 2019, Postal Inspector Brandon was notified that the SUBJECT PARCEL had arrived at the undercover address.

On January 7, 2019, Postal Inspector Michael Kaminski took custody of the SUBJECT PARCEL and transported it to the U.S. Postal Inspection Service, Phoenix Headquarters, for evidence processing. The SUBJECT PARCEL is described as follows: One USPS First-Class parcel with a return address of "Gift card LLC, 6409 N. Scottsdale Rd., Scottsdale, AZ 85253." It is a manila envelope; measuring approximately 4" X 7"; mailed on 12/31/18 from a SSK at the Cactus Station, located at 2901 E. Greenway Rd., Phoenix, AZ 85032; with \$1.00 in postage.

On January 11, 2019, Postal Inspectors McClamrock and Postal Inspector Shepard processed the SUBJECT PARCEL and contents, which revealed the following: one manila envelope and one small blue zip lock baggie containing a white crystallized substance. The total weight of the baggie and white crystallized substance was approximately 4.0 grams. Postal Inspector McClamrock conducted a TruNarc drug identification test (scan 329), which resulted in a positive alert for methamphetamine.

EXAMINATIONS:

Examine exhibits 11, 12, 13, 14, 15, 16, 17 and 18, for the presence of controlled substances and determine the quantity and purity, as appropriate.

FINDINGS AND OPINIONS:

Exhibit 11 consists of one (1) plastic bag containing another plastic bag containing brown chunky material. The net weight of the material was 617.2 ± 1.1 grams. A sample of the material was analyzed and found to contain heroin hydrochloride.

Exhibit 12 consists of a plastic bag containing four (4), light-blue, round, biconvex tablets impressed with "M" on one side and a "30" on the scored side. The total net weight of the tablet material was 0.4047 ± 0.0009 gram. A sample of the material from each item was analyzed and each was found to contain fentanyl ("salt form" undetermined). Two of the tablets also contained FUB-AMB and N-ethylhexedrone; and the other two contained 4-Anilino-N-phenethylpiperidine (4-ANPP).

Exhibit 13 consists of a plastic bag containing two (2), light-blue, round, biconvex tablets impressed with "M" on one side and a "30" on the scored side. The total net weight of the tablet material was 0.2369 ± 0.0009 gram. A sample of the material from each item was analyzed and each was found to contain fentanyl ("salt form" undetermined). One of the tablets also contained 4-ANPP.

Exhibit 14 consists of a plastic bag containing two (2), light-blue, round, biconvex tablets impressed with "M" on one side and a "30" on the scored side. The total net weight of the tablet

material was 0.2155 ± 0.0009 gram. A sample of the material from each item was analyzed and each was found to contain fentanyl ("salt form" undetermined) and 4-ANPP.

Exhibit 15 consists of a plastic bag containing two (2), light-blue, round, biconvex tablets impressed with "M" on one side and a "30" on the scored side. The total net weight of the tablet material was 0.2140 ± 0.0009 gram. A sample of the material from each item was analyzed and each was found to contain fentanyl ("salt form" undetermined) and 4-ANPP.

Exhibit 16 consists of a plastic bag containing four (4), light-blue, round, biconvex tablets impressed with "A" over "215" on the scored side and were plain on the other side. The total net weight of the tablet material was 0.3459 ± 0.0009 gram. A sample of the material from each item was analyzed and each was found to contain cocaine ("salt form" undetermined) and N-ethylhexedrone.

Exhibit 17 consists of a plastic bag containing two (2), light-blue, round, biconvex tablets impressed with "M" on one side and a "30" on the scored side. The total net weight of the tablet material was 0.2078 ± 0.0009 gram. A sample of the material from each item was analyzed and each was found to contain fentanyl ("salt form" undetermined) and 4-ANPP.

Exhibit 18 consists of a plastic bag containing four (4), light-blue, round, biconvex tablets impressed with "M" on one side and a "30" on the scored side. The total net weight of the tablet material was 0.4133 ± 0.0009 gram. A sample of the material from each item was analyzed and each was found to contain fentanyl ("salt form" undetermined) and 4-ANPP. One tablet was also found to contain delta-9-tetrahydrocannabinol (D-9-THC) and another was found to contain cocaine ("salt form" undetermined).

Seventeen (17) of the twenty (20) tablets examined also contained acetaminophen.

The fentanyl, FUB-AMB, 4-ANPP, cocaine and D-9-THC found in exhibits 12 through 18, were identified by gas chromatography (GC) and mass spectrometry (MS). The N-ethylhexedrone found in exhibits 12 and 16 was identified by GC/MS. The heroin hydrochloride in Exhibit 11 was identified using infrared spectroscopy, GC and MS. All reported uncertainties are based upon $k=2$, at a 95% confidence level.

REMARKS:

The tablets covered by this report appear to be illicitly made because their contents do not match that of the licit tablets as described in the following:

Visual examination of the physical characteristics, of the "M" / "30" tablets, including shape, color, and manufacturer's markings is consistent with a pharmaceutical preparation containing oxycodone hydrochloride, 30 mg, manufactured by Mallinckrodt Pharmaceuticals.

Visual examination of the physical characteristics, of the "A / 215" tablets, including shape, color, and manufacturer's markings is consistent with a pharmaceutical preparation containing oxycodone hydrochloride, 30 mg, manufactured by Actavis Pharma, Inc.

N-ethylhexedrone is a homologue of N-ethylbuphedrone, which is a DEA Schedule I substance.



A number of other substances of interest were also indicated (but not confirmed) throughout. Exhibit 12 gave indications of flualprazolam (also known as 2'-fluorodiazepam). Exhibit 16 gave indications of: 4-chloro- α -PVP (also known as 4-chloro- α -Pyrrolidinopentio-phenone) and diclazepam (also known as 2'-chlorodiazepam) in three of the four tablets.
