

Massachusetts, July 2022 - January 2023

A review of the counterfeit medicine news coming out of Massachusetts since mid-2022 paints a bleak and dangerous picture. While all states are dealing with counterfeit pills made with fentanyl, Massachusetts is facing a few other issues: counterfeit Adderall pills made with methamphetamine and drug traffickers using pill presses to manufacture and distribute pills locally. When combined, these three issues create a dangerous powderkeg for communities not just in Massachusetts, but throughout New England.

Fake medicine has found its way into Massachusetts from places other than street corners or social media apps. In January 2023, a member of a ring that illegally imported and sold millions of prescription pills to Americans, including some in Massachusetts, was sentenced. Sometimes, members of the medical profession have purchased medicine from unlicensed sources. Between 2012 and 2016, the U.S. Food and Drug Administration sent letters to 59 doctors and medical practices across Massachusetts warning them to stop buying medicine from known black market wholesalers. These letters were in reference to cancer medications and Botox.
