New Jersey, July - December 2022

Counterfeit medicine news streamed steadily out of New Jersey in the second half of 2022. The U.S. Department of Justice indicted four men - two from Newark, one from North Haledon, and one from Kearny - for their roles in a multi-year fake pill drug ring whose pills prosecutors alleged were responsible for at least three overdoses. A Middlesex County man received a nine-year prison sentence for manufacturing hundreds of thousands of counterfeit Xanax pills that were sold to customers across the U.S. via darknet storefronts. A retired Mays Landing doctor was sentenced for selling misbranded weight-loss pills that he made out of a toxic substance never approved for human consumption.

Counterfeit medicine has also made its way into New Jersey when members of the medical profession purchased medicine from unlicensed sources. Between 2012 and 2016, the U.S. Food and Drug Administration sent letters to 130 doctors and medical practices across the Garden State warning them to stop buying medicine from known black market wholesalers. More recently, a total of seven companies and individuals were named in a massive lawsuit filed by Gilead Sciences over the trafficking of counterfeit HIV medicines in 2021.
