



## Prescription Drugs States Seek to Import from Canada

### Purpose

This is a living document maintained by the Partnership for Safe Medicines (PSM). Within it, you will find a collection of all the drug lists from known drug importation applications (SIPs), including previous versions superseded by subsequent filings.

In 2003, the Medicare Modernization Act included a provision to allow states to import prescription drugs from Canada as long as doing so would not endanger patients and that it would give significant savings to the American consumer. A federal rule was not finalized until 2020. [That finalized rule can be seen here](#) and it governs the requirements of any state's application to the FDA to operate a program to import medicine from Canada. As part of a Section 804 program application, a state needs to provide a list of drugs they seek to import.

### Methods

The drug lists were collected in one of three ways:

1. A state publicly published the SIP application containing the drug list
2. PSM obtained the information through a Freedom of Information Act (FOIA) request
3. The information was obtained from public evidence from ongoing litigation.

### Notes

As of January 29, 2024, legislators in Colorado, Connecticut, Florida, Maine, New Hampshire, New Mexico, Texas, and Vermont have drafted applications though not all to the same level of detail. To the best of PSM's knowledge, **Connecticut, Maine, Texas, and Vermont** have not submitted drug lists. If/when a state does, that information will be included in this document.

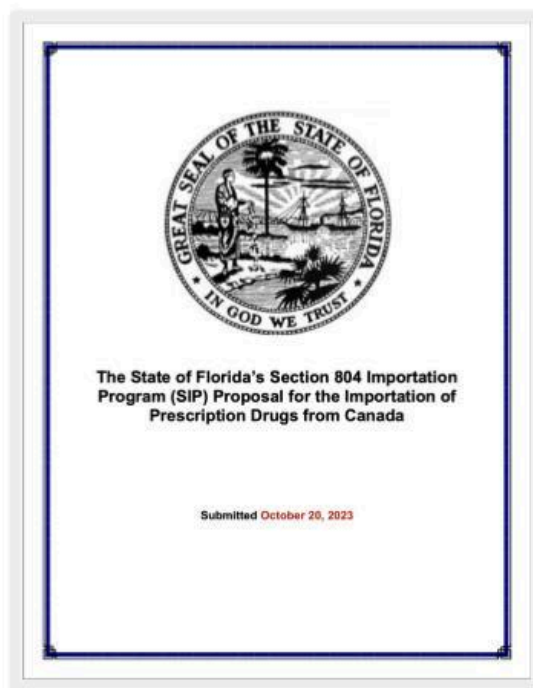

This attachment incorporates by file a document for each drug identified below. For each drug, the Agency intends to import all strengths and dosage forms listed on the cover sheet. The Agency does not intend to import any approved dosage form or strength combination not listed on the cover sheets. Each file contains:

- **A drug label cover sheet** providing each eligible prescription drug's FDA-approved counterpart, the manufacturer(s) of the finished dosage form and the active ingredient or ingredients of each eligible prescription drug that the SIP Sponsor seeks to import, the legal relationship of these entities to the SIP Sponsor, and information about the HPFB-approved product and its FDA-approved counterpart. Unless otherwise specified, information on each of the cover sheets, including proprietary/brand names, active ingredients, inactive ingredients, and dosage forms, are identical for both HPFB- and FDA-approved products and will not be listed separately. Ingredient names referring to the same chemical entity may be different between HPFB-approved monographs and FDA-approved labels. A list of such entities will be provided at the end of this document.
- **The proposed label and side-by-side comparison** of proposed label to FDA-approved drug label, including the Prescribing Information, carton and container labeling, and patient labeling (e.g., Medication Guide, Instructions for Use, patient package inserts), with all differences annotated and explained.
- **The proposed package insert.**
- **The FDA-approved package insert.**
- **The HPFB-approved package insert.**
- **Marketing Status in the United States.**

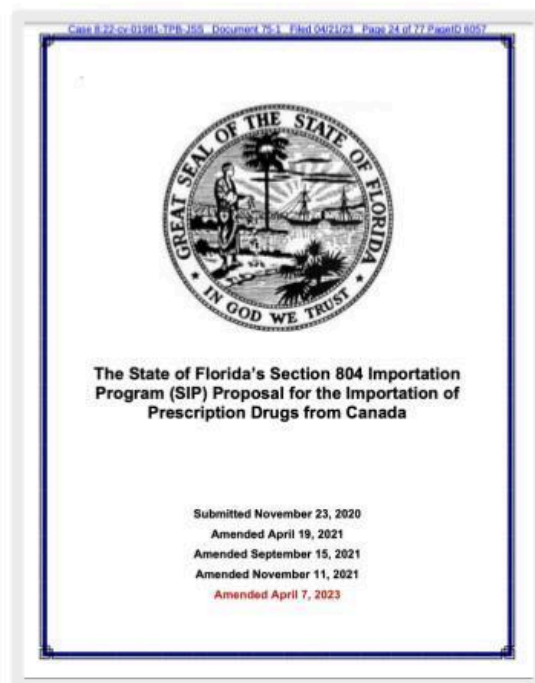

## Florida's List of Prescription Drugs to Import

The FDA rule requires the SIP to include the following information related to the prescription drugs that will be imported:

- Names and Drug Identification Numbers (DIN) of selected drugs to import.
- Information of the applicant that holds the New Drug Applications (NDA) or Abbreviated New Drug Applications (ANDA).
- Name and address of the manufacturer of the finished dosage form.
- Names and addresses of manufacturers of the prescription drugs and active ingredients.

As part of this proposal, the State is providing the list of prescription drugs it will initially attempt to import under the SIP. The final list of imported prescription drugs is subject to change and can be addressed in an amended SIP or through the pre-import request, based on the FDA's preference. At the time of this submission, the State does not know the addresses of the manufacturers' facilities that produce the finished dosage forms or active ingredients.

Florida has chosen a limited set of drugs that will yield the highest potential savings. Also, these specific medications allow Florida the best opportunity to maximize the importation program's benefits while remaining compliant with federal law. After the program has proven to be a success, the State intends to amend its SIP to expand the list of medications that will be imported.

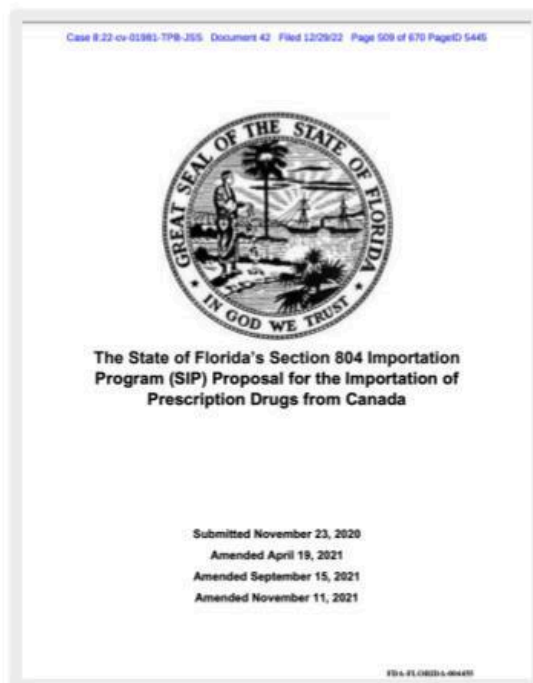

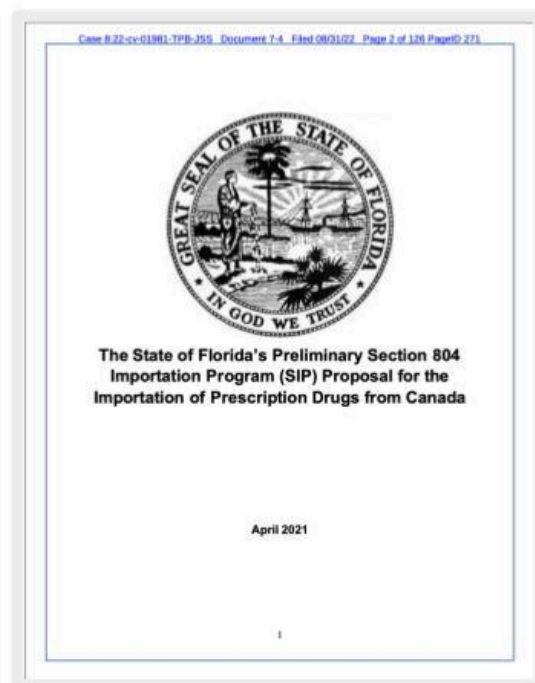

## Florida's List of Prescription Drugs to Import

The FDA rule requires the SIP to include the following information related to the prescription drugs that will be imported:

- Names and Drug Identification Numbers (DIN) of selected drugs to import
- Information of the applicant that holds the New Drug Applications or Abbreviated New Drug Applications
- Name and address of the manufacturer of the finished dosage form
- Names and addresses of manufacturers of the prescription drugs and active ingredients

As part of this proposal, the State is providing the list of prescription drugs it will initially attempt to import under the SIP. Since the State has not finalized an agreement with a foreign seller and has not secured agreements from manufacturers, the final list of imported prescription drugs is subject to change and can be addressed in an amended SIP or through the pre-import request, based on the FDA's preference. The State will also update the list of prescription drugs with the manufacturer information once that is confirmed (known).

Florida has chosen a more limited set of eligible prescription drug classes for which to initiate its importation program, focusing on medications that are used to treat certain conditions (e.g., HIV/AIDS, asthma, chronic obstructive pulmonary disease, diabetes, etc.) and that will yield the highest potential savings. Also, these specific medications allow Florida the best opportunity to maximize the importation program's benefits while remaining compliant with federal law. After the program has proven to be a success, the State intends to amend its SIP to expand the list of medications that will be imported.

The below chart outlines preliminary information necessary for these prescription drugs as it applies in both the U.S. and Canada.

## Florida's List of Prescription Drugs to Import

The FDA rule requires the SIP to include the following information related to the prescription drugs that will be imported:

- Names and Drug Identification Numbers (DIN) of selected drugs to import
- Information of the applicant that holds the New Drug Applications or Abbreviated New Drug Applications
- Name and address of the manufacturer of the finished dosage form
- Names and addresses of manufacturers of the prescription drugs and active ingredients

As part of this proposal, the State is providing the list of prescription drugs it will initially attempt to import under the SIP. Since the State has not finalized an agreement with a foreign seller and has not secured agreements from manufacturers, the final list of imported prescription drugs is subject to change and can be addressed in an amended SIP or through the pre-import request, based on the FDA's preference. The State will also update the list of prescription drugs with the manufacturer information once that is confirmed (known).

Florida has chosen a more limited set of eligible prescription drug classes for which to initiate its importation program, focusing on medications that are used to treat certain conditions (e.g., HIV/AIDS, asthma, chronic obstructive pulmonary disease, diabetes, etc.) and that will yield the highest potential savings. Also, these specific medications allow Florida the best opportunity to maximize the importation program's benefits while remaining compliant with federal law. After the program has proven to be a success, the State intends to amend its SIP to expand the list of medications that will be imported.

The below chart outlines preliminary information necessary for these prescription drugs as it applies in both the U.S. and Canada.

At any level in the supply chain where there is no market competition, the state can establish a limit on mark-up or fees for each stage of the supply chain. The allowed mark-up will account for the routine and exceptional costs of importing and distributing product throughout the state. The mark-up limits for the non-competitive parts of the supply chain will be enforced by payers and purchasers who will know the import price and the state margin limits. In order to ensure the significant savings from importing certain prescription drugs wholesale from Canada would be passed on to consumers, New Hampshire could amend its annual rate review filing requirements for health plans doing business in the state and require health plans to document savings from importation as well as how those savings were passed on to consumers.

Options for passing savings to consumers may include:

- Lowering premiums.
- Lowering deductibles, and
- Reducing or eliminating co-pays.

In addition to the rate review process described above, the New Hampshire would establish a transparent, public price list of the imported drugs in order to ensure that mark-up along the supply chain was not exceeding the allowed amount at the expense of consumer savings.

### Conclusion

Now more than ever, one of the biggest pressures on New Hampshire families' pocketbooks is the high cost of health care in the Granite State and prescription drugs are a driver of these health care costs. We look forward to the Administration's continued action to create a formal pathway for prescription drug importation from Canada and to its partnership with states on this important initiative.

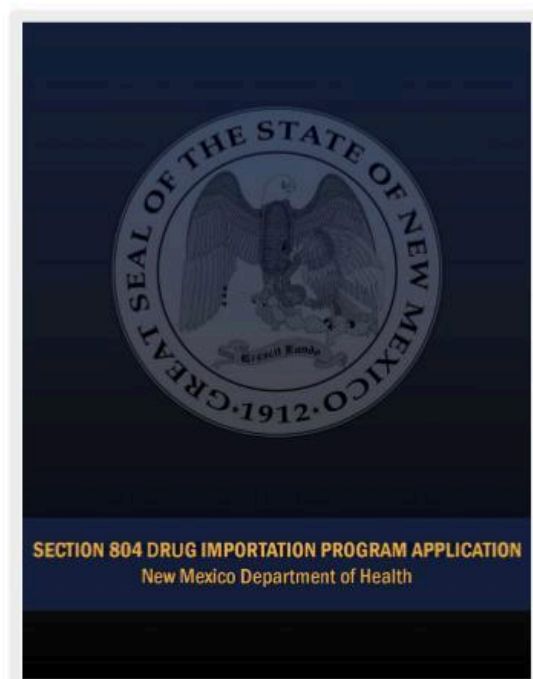

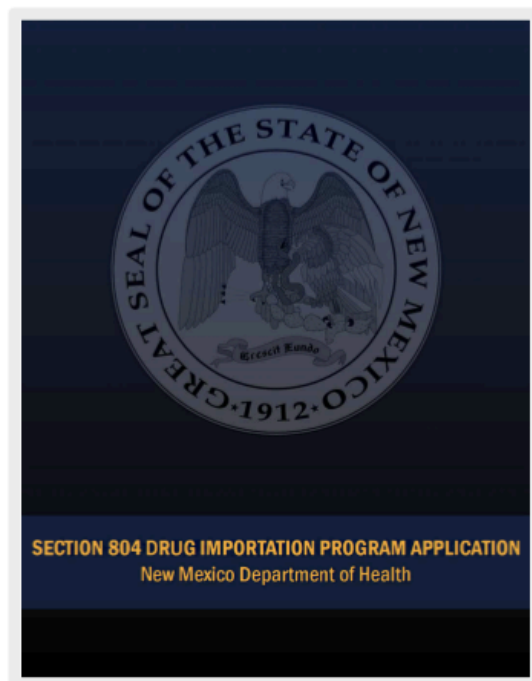
